

Tigui Mining Group Expands in Côte d'Ivoire

In negotiation with the government to acquire gold and diamond exploration licenses

Tigui Mining Group is finalizing a semiindustrial project for gold exploration with a local cooperative in Côte d'Ivoire, in the region of Odienné, located in the northwestern part of the country.

Production will start within 3 months. Tigui Mining Group controls 100% of the operation.

Tigui Mining Group is officially registered in Cote d'Ivoire under Tigui Mining Group Côte d'Ivoire, TMG-CI.

Activities in Cote d'Ivoire will focus on mining, agriculture, oil, infrastructure and real estate.
